## **GENERAL TERMS AND CONDITIONS**

The General Terms and Conditions apply to all services provided by AERCO.

Any order or use of an airport public service or other services constitutes express, complete and unreserved acceptance of these General Conditions, unless otherwise agreed in writing.

#### **Royalties and Tariffs**

The fees and tariffs are established and modified in application of the provisions of the Concession Agreement for the International Airports of the Republic of Congo (signed on 14 December 2009).

The fees and rates presented in this document are the basic reference applicable to all AERCO customers.

Tariffs of charges are published on the AERCO websites (www.brazzaville-aeroport.com and www.pointenoire-aeroport.com). They can also be obtained on request from AERCO management and from the management of Brazzaville and Pointe-Noire airports.

In accordance with the provisions of the Convention on the Concession of International Airports of the Republic of Congo, the so-called regulated fees (or aeronautical fees mentioned in Chapter I below) are revised by the Congolese State.

In addition, AERCO is authorized to review unregulated tariffs and charges. Unregulated tariffs and charges are revised annually by decision of AERCO's Board of Directors to take into account the level of inflation and the investments to be made. They may also be revised at any time, in case of justified economic necessity, and following the procedure described above.

Any changes made to the conditions for setting and collecting rates and charges shall be brought to the attention of AERCO's customers at least one month before the date on which they are to be implemented.

#### Tax regime.

The prices presented in this document are exclusive of VAT. In accordance with the legislation in force, the fees, charges and services that may be subject to VAT will be subject to the application of VAT at the rate in force, as well as the collection of additional cents at the rate in force.

The holder of a Temporary Occupancy Permit (TOP) for the granted domain will directly pay all taxes and duties incumbent upon him/her, in accordance with the legislation in force, in particular registration fees, so-called rental taxes and all taxes and duties related to the operation of the occupied premises.

#### Invoicing

Invoices are issued according to the information transmitted by the customers (identity, billing address, ...).

Summary invoices for aeronautical services shall consist of the charges related to all aircraft movements of the customer for the period concerned. They cannot be separated.

Invoices are issued in duplicate and accompanied by a descriptive slip detailing the service.

## Terms and conditions of payment

<u>Aeronautical charges</u> are, as a matter of principle, payable in cash, prior to any take-off for all companies or individuals.

However, an application to open an account may be submitted. The opening of the account may be refused when:

- The operations invoiced are not of a permanent nature,
- The amounts invoiced are too low to justify keeping an account, (any invoice below 30 Euros HT or 19 700 XAF is payable in cash),
- The user has not provided AERCO with sufficient security for the payment of bills.

<u>State and commercial royalties</u>, as well as invoices for <u>energy supply</u> and <u>services of</u> all kinds are payable under the conditions indicated in the contracts drawn up between AERCO and the customer.

Apart from invoices payable in cash and unless explicitly agreed otherwise in the contract, invoices must be paid within 30 days of receipt.

Bank charges relating to payments made through banking institutions are to be borne by the customer, who must stipulate on his order: charges to be borne by the issuer.

#### Late payment interest

Claims are not suspensive of payment.

Any delay in payment shall automatically entail, after a period of 30 days, an increase of 1% per month, indivisible and automatically applicable without prejudice.

In the event of non-payment within the deadline and after sending a formal notice, the file is sent to the legal department for recovery.

AERCO may, depending on the circumstances:

- Demand immediate payment for all invoiced services;
- After a simple formal notice, call up the guarantees set up;
- Require prepayment or cash payment for all new services.

In addition, forwarding the file to the legal department may result in the termination, as a penalty, of the temporary occupation permit (AOT) agreements from which the debtor benefits.

#### Deposit and security deposit

Prior to any occupation of the Concession Area, AERCO will require the occupant to pay a security deposit equal to three (3) months of royalties. This security deposit is non-interest bearing.

For airlines that wish to benefit from payment deadlines, AERCO also reserves the possibility of requiring a security deposit, the amount of which is assessed on the basis of the average amount of the fees due.

Amounts received by AERCO as a guarantee or security deposit are used to discharge the company's or occupant's debts in the event of default. They can also be used to refurbish the premises at the end of occupation.

## Provisions applicable to aircraft operators

In the event of non-payment of the charges due by an aircraft operator, AERCO shall be entitled to request from ASECNA that one or more aircraft owned or operated by the said operator be grounded until full payment of the amount in question has been made. In the case of aircraft owned or operated by a natural or legal person represented in the Republic of Congo, the decision to ground the aircraft shall be enforceable in the event of a formal notice to the debtor (by a bailiff) that has remained unsuccessful.

## Limitations of liability.

Whatever the cause, AERCO's possible liability will be limited to direct damage only and to the exclusion of consequential and non-consecutive immaterial damage within the contractual limits of the insurance policies taken out by AERCO, the amount of which can be obtained on request.

Aircraft or motorized land vehicles parked at airports granted to AERCO remain under the sole responsibility of their owner or holder, as AERCO does not assume the status of custodian.

## Applicable law and dispute resolution

The French text is authentic as the original General Terms and Conditions. The present General Conditions are subject to Congolese law. Any dispute relating to the interpretation or execution of these Terms and Conditions shall be subject to the exclusive jurisdiction of the Congolese courts within whose jurisdiction the airport concerned is located.

Any overload or deletion of these Terms and Conditions shall be considered null and void.

## I. RATES OF AERONAUTICAL FEES

## **General principles**

Any flight whose departure and arrival points are located in land areas and adjacent territorial waters over which the Congo exercises sovereignty, protection or trusteeship shall be considered national traffic.

All other flights are considered international traffic.

#### Information to be provided to the Airport

#### Device data

Landing and parking charges will be calculated using the MTOW of the aircraft used.

Customers are responsible for informing AERCO's invoicing department of any changes made to their fleet: purchases, sales, rentals, leases, modifications to aircraft characteristics, etc., failing which they will be invoiced for services based solely on the characteristics known to AERCO.

Updates will be taken into account as of the next billing, without retroactive effect.

#### Traffic data

Irrespective of the nature of its traffic, the air operator or its representative (which may be the handling organization) must inform the billing department of the breakdown of the load into passengers, freight and mail per stopover.

This breakdown will distinguish passengers benefiting from a total exemption from charges from other passengers. These are the:

- → Personnel whose service on board is directly related to the flight (e.g. crew members performing teflight),
- Passengers in direct transit making a temporary stop at the Airport and departing on the same aircraft twith a departure flight number identical to the flight number of the aircraft on which they arrived.
- Passengers of an aircraft that has been forced to return to the Airport due to technical incidents or adverse weather conditions,
- > Passengers on an aircraft making a technical stopover,
- > Children under 2 years old.

In the absence of this information, invoicing will be based on the maximum capacity of the aircraft (last fleet data transmitted or manufacturer's default data), and no retroactive credit note will be issued.

#### Miscellaneous data

Any information likely to affect invoicing must be transmitted without delay to the department in charge of invoicing: change of invoicing address, change of IATA or ICAO code, change of airport assistant, change of aircraft owner or operator.

#### Landing fees

This is the charge levied for any aircraft landing at one of the airports licensed to AERCO. The landing charge corresponds to the use of the airport infrastructure and equipment necessary for landing, take-off and taxiing.

Landing fee revenue is collected by AERCO on the basis of the maximum take-off weight (MTOW) shown on the aircraft's certificate of airworthiness and rounded up to the nearest tone. A minimum fee shall apply.

Charging rates differ depending on whether the aircraft is on a domestic or international flight. A domestic flight shall be any flight whose point of departure and arrival is situated in the territory of the Republic of the Congo and which does not include any commercial stopover in other territories.

The fee is payable by the aircraft operator or (in the absence of such an operator) by the owner of the aircraft.

Aircraft forcibly returning to the airport due to technical incidents or adverse weather conditions are exempt from the landing fee.

The landing fee does not include any assistance service.

Landing fees at Congo's international airports shall be set as follows:

In accordance with the Civil Aviation Code of CEMAC, the following aircraft are exempt from the landing fee:

- Civil flights operated by State aircraft provided that such flights are not operated for commercial purposes and subject to reciprocity;
- → Military flights of States having concluded reciprocal agreements with CEMAC Member States;
- > Search and rescue flights authorized by a competent body;
- Flights performed for the purpose of checking or testing ground equipment used or intended to be used as an aid to air navigation.

Aircraft from flying clubs are also exempt from the landing fee if they only operate training flights.

Some special conditions are granted to specific users, such as:

- Rotorcraft benefit from a 50% reduction on the current rate;
- Aircraft belonging to a transport or aerial work company which carry out training flights without anytransport or paid work, benefit from a 75% reduction on the rate in force each time they use the procedure without making a full landing (touch and go).

#### Parking fees

The parking fee is levied for parking after deduction of the free parking period (franchise) that has elapsed.

The parking charge is calculated per hour of parking based on the MTOW at take-off on the aircraft's certificate of airworthiness, rounded up to the nearest ton, as shown on the current year's VERITAS record.

The parking time is calculated between the arrival block time and the departure block time recorded by the airport operator.

A two (2) hour free allowance is granted starting from the "block" time of arrival of the aircraft.

Beyond this deductible, every hour started is due.

<u>N.B</u>: Aircraft of based companies that remain non-operational while parked on the aerodrome are billed after a period of 2 months at the same rate as non-based aircraft.

## **Passenger Fee**

The charge per passenger corresponds to the use of facilities for the embarkation, disembarkation and reception of passengers and the public, as well as the provision of check-in and boarding counters and baggage handling facilities.

The following fares do not include the mission of assistance to persons with reduced mobility (APMR) which is subject to a specific fee.

The charge is payable for any passenger boarding an aircraft operated for commercial or non-commercial purposes.

Passenger information shall be provided by the airline concerned or by its ground handler and shall be communicated at the latest on the day of the flight to the following address

If this information is not transmitted on the day of the flight, AERCO reserves the right to charge the airline for the maximum capacity of the aircraft, without prejudice to any measures it may take to ensure the regular transmission of this information.

The following shall be exempted from the payment of the passenger charge:

- → Crew members;
- Passengers making a temporary stop at the Airport and departing on the same aircraft and with the same flight number as the arriving aircraft;

- Passengers on aircraft that have been forced to return to the Airport due to technical incidents or adverse weather conditions:
- > Passengers on an aircraft making a technical stopover;
- → Children under 2 years of age.

#### Fuel supply charge

The fueling charge is due and paid by all airlines whose aircraft are fueled at the parking areas of Brazzaville, Pointe-Noire or Ollombo airports.

## Charge for the use of facilities for the reception of freight and mail

The fee for the use of facilities for the reception of freight shall be payable for the use of the works and premises of common use used for loading, unloading and all goods handling operations, which include freight and mail.

The charge shall be collected at the time of embarkation and disembarkation of cargo, except for domestic flights for which the charge shall be collected at the time of embarkation only.

The fee is set at different rates, depending on the geographical area of origin or destination of the goods.

The rates of this charge shall be expressed in CFA francs per kilogram, the weight in question being rounded up to the next higher kilogram.

## II. RATES FOR FACILITY USE FEES

#### Fee for the use of check-in desks and equipment for the processing of passengers and baggage.

A fee is charged for the provision of the registration banks.

The fee shall be payable for any use of the common-use equipment used to process flights at check-in. The use of the software allowing access to the airlines' Desk Control Systems (DCS) is billed separately (see below), as are supplies and consumables.

The charge is payable by the airline. In case of self-assistance or special agreement, by the assistance company.

The rate of the fee is fixed per registration bank and per hour ¼ (any hour ¼ started is due).

## Gateway user fee

The charge for the use of aircraft access gangways is payable by any aircraft that, while parked at airports managed by AERCO, uses one of the gangways to carry out passenger boarding or disembarking operations.

The rate of the Aircraft Access Bridge User Charge is expressed in CFA francs per quarter-hour regardless of the type, origin or destination of the aircraft, with any quarter-hour started being due.

The fee is payable by the Operator of the aircraft or, failing that, by the owner.

In the case of parking for more than two hours, the aircraft will be required to leave the bridge contact to park at a remote location once disembarkation operations have been completed. However, if traffic conditions permit, the AERCO concessionaire may authorize the aircraft to remain in contact with the bridge for the duration of its stopover.

#### Fee for treatment of accidental spills in a reserved area.

The intervention will be invoiced and set up by AERCO following the observation of pollution that has not been treated by the polluter.

Any degradation caused by pollution will be invoiced to the polluter after evaluation by AERCO's services.

## Out-of-hours opening fee (Ollombo)

In accordance with Article 37.2 of the Concession Agreement, Ollombo Airport is open to traffic from 5:00 GMT to 21:00 GMT, 7 days a week.

Outside these hours, Ollombo airport may be opened to traffic in return for a fee payable by the applicant, the rate of which is fixed at CFAF 100 000 exclusive of tax per two-hour period.

## Temporary Storage Fee for Freight on the Parking Area

Any goods stored for more than 4 hours from the arrival of the aircraft will be invoiced on the basis of **200 000 FCFA HT** / hour of occupancy.

## Fees for the use of the Ebène lounges

The user fees of the Ebony Lounges are due for any use of these lounges and the services offered by the teams assigned there in assisting passengers during police formalities and the supply of drinks, newspapers, etc...

The fee is payable by the Company issuing the card to the passenger or by the passenger paying it to the relevant AERCO Service.

## **III. RATES OF STATE ROYALTIES**

The land and building occupancy fee are payable for the private occupation of land or buildings located within the perimeter of the airports granted to AERCO. This occupation is subject to the general and specific regulations defined in the framework of Temporary Occupancy Authorization (TAO) agreements for the area granted to AERCO.

Land and building occupancy fees are payable annually, quarterly or monthly in advance.

The offices, premises and counters are supplied as they are with the usual connections (electricity, distribution, telephone, possibly climatic comfort).

The storage areas and sheds are supplied as is with electrical connections.

The rates below are exclusive of taxes and charges.

The rates for services (not detailed in the table above) are to be determined on a case-by-case basis upon occupancy of the premises. A flat-rate charge is applied for specific services, details of which can be consulted at AERCO's State Department.

## IV. TARIFFS FOR RENTAL CHARGES AND MISCELLANEOUS

In consideration for the various services and performances rendered by the Licensee, the Licensee is entitled to receive payment for such services and performances, as well as various fees.

The nature, conditions of establishment and collection, and the rates for such services and fees shall be fixed in relation to the services and supplies rendered.

## **Electricity**

Billing unit: Kwh

The supply of electricity is invoiced monthly:

- Either on the basis of billing based on the actual KWh consumed, for premises with their own meter.
  - Either on the basis of flat-rate billing based on a power balance established between the Parties, for premises that do not have their own meter.

#### Charges for the use of internal telephony services at the airport

The fee is due for any use of the internal telephone network provided by AERCO.

The fee is set, based on unlimited access to the internal network, according to the type of telephone chosen by the user.

The subscription covers:

- → Telephone line and switch maintenance costs;
- → The maintenance costs of the telephone set;
- → Access to the internal telephone network.

Television network connection fees are established for all new installations according to the location chosen and are payable in advance.

These fees include:

- The purchase of the cable;
- > Connection accessories;

Audiovisual fees due to the Ministry of Supervision as well as broadcasting rights for public places are the responsibility of the client.

## V. ROYALTY ON TRADE CONCESSIONS

The commercial fee shall be payable by any economic operator carrying on a commercial activity in the airport area. It pays for the authorization to carry out commercial activity at airports.

The rate of the commercial fee shall be a percentage of the operator's turnover or commercial margin on the platform, with a guaranteed minimum annual amount if necessary.

It is set by:

- Agreement party between AERCO and the beneficiary of the AOT agreement;
- Depending on the nature of the commercial activity carried out;
- And the projected turnover.

The commercial fee may be fixed on a flat-rate basis for beneficiaries who have difficulties in declaring turnover.

The conditions of establishment and collection are the subject of specific agreements.
